Financial results at 30.09.2021

The activity of the company Şantierul Naval Orşova SA during the 9 months of this year was very much influenced by the unfavorable global / European context of the evolution of the demand for the construction of new ships, river and sea. The fact that the demand for shipbuilding and the rental of existing ones on the market has been decreasing from one period to another, has largely determined the evolution of their prices, which has followed the same decreasing trend, given that prices at raw materials and materials, energy, gas, labor increased or, at best, stagnated.

The company, although achieved in the first 9 months of 2021 a turnover of 49,946,187 lei, increasing by 2% compared to the same period of the previous year, however, as shown in the table below, the total activity is recorded a gross loss of 49,644 lei (on 30.09.2020 there is a gross profit of 3,685,009 lei) and a net loss of 559,251 lei (in the corresponding period of 2020 a net profit of 3,411,073 lei was achieved).

During 01.01-30.09.2021, the operational revenues, in the amount of 50,016,895 lei, decreased by 0.74% compared to those registered at 9 months in 2020 (50,392,080 lei). The operational expenses, in the amount of 50,693,383 lei, in the 9 months of 2021 registered an increase of 7.47%. compared to their level in the similar period of 2020 (47,170,530 lei).

The loss from the operational activity registered at the end of the 9 months of 2021 was of 676,488 lei, this in the conditions in which at the main headquarters in Orşova from the shipbuilding activity was realized an operating profit of 675,930 lei, and the Agigea branch registered a loss from this activity of 1,352,418 lei.

From the financial activity, the company made in this period a profit in the amount of 626,844 lei, by 317.9%, higher than the budgeted one and by 35.25% higher than the one realized in the 9 similar months of 2020.

In the period 01.01-30.09.2021 the company Santierul Naval Orsova S.A .. achieved the following financial results:
