Financial results at 30.09.2024

Societeatea Santierul Naval Orsova S.A. achieved in the period 01.01-30.09.2024 a turnover of 72,205,255 lei, lower by 11.72% compared to the same period of the previous year and, as can be seen from the table below, on total activity a gross profit of 6,999,668 (on 30.09.2023 a gross profit of 4,462,476 lei was recorded) and a net profit in the amount of 5,621,259 lei (in the corresponding period of 2023 a net profit of 3,984,405 lei was recorded).

In the period 01.01-30.09.2024, operational revenues, in the amount of 72,455,882 lei, decreased by 11.77% compared to those recorded in the similar period of 2023 (82,125,491 lei). The operational expenses, in the amount of 66,135,845, and in close correlation with the operational revenues, in the 9 months of 2024 also registered a decrease of 15.06%. compared to their level from the similar period of 2023 (77,863,065 lei).

From the financial activity, influenced by the evolution of the exchange rate, but also from the placements of availabilities in interest-bearing time deposits, the company achieved during this period a profit in the amount of 679,668 lei, 239.73% higher than the one achieved in the 9 similar months of 2023 (200,050 lei).

In the period 01.01-30.09.2024 the company Santierul Naval Orsova S.A. recorded the following financial results:
